In order for Nye County to participate in the license application process, it must make available all of its documents that are relevant to licensing on a web accessible server which is able to be canvassed by the NRC's web indexing software.</p> <p>The subject plan describes the Nye County Nuclear Waste Repository Project Office (NWRPO) process for planning, developing, implementing, and maintaining the NWRPO Licensing Support Network (LSN) system.</p>
